1.3 EXPLANATION OF GRAPHS

The graphs used in this report include standard deviation, which has been used as a means of objectively measuring how much the crime rate has varied over time and is useful in identifying extreme highs and lows of crime. Standard deviation has been used so that where the crime rate is above the red line (2 standard deviations above the mean average), it is considered exceptionally high. Where the crime rate is below the blue line (2 standard deviation below the mean average), it is considered exceptionally low. In both cases it can be referred to as statistically significant (high or low) and is an indication of whether the quarterly statistics are exceptionally high or exceptionally low.

1.4 AIM

The aim of this report is to produce accurate, timely, objective information that:

- Enables informed decisions to be made on the types of crime that threaten the safety of the community.
- Is used to proactively manage risks to the island and ensure effective policing, redeploying and directing resources at a strategic and tactical level, as required.
- Facilitates effective and open communication with our stakeholders, developing the means to inform them of the plans, efforts and progress being made by the BPS.
- Provides meaningful information as one of the means of reassuring communities in Bermuda.

¹ Crimes Against The Person has increased by 1 crime in Q1 2014 due to the re-classification of the murder suicide of Myron and Regina ROBINSON while in Q3 2014 a serious assault was re-classified as a murder due to Shijuan MUNGAL's death.

1.5 Executive Summary

In 2014 there were **4** people murdered; of which **2** were by firearms and **2** by weapons. **8** people suffered from firearm related injuries. In 2013, **5** people were murdered, of which **3** were by firearms. **5** people suffered from firearm related injuries.

All Crime Offences (Crimes Against The Person, Crimes Against The Community and Crimes Against Property) in **Q4 2014** totalled **896**, an **increase** of **+49** offences or **+5.8%** when compared to Q3 2014. Q4 2014 presents the **10th quarter in a row whereby offences have remained under 1,000 per quarter**. All crime offences in 2014 totalled **3,393**, a **decrease** of **-87** offences or **-2.5%** when compared to 2013. A summary of the 3 key crime headings and 20 crime categories for Q4 2014 in comparison to the previous quarter (Q3 2014), the same quarter last year (Q4 2013) and the 5 year trend is shown below in figure 1:

2. ALL CRIME

2.1 SUMMARY


Figure 3: All Crime (Last 5 Year comparison 2010 – 2014)

The total for All Crime in **Q4 2014** was **896**, an **increase** of **+49** offences or **+5.8%** compared to Q3 2014. When compared to 2013, all crime for 2014 has **decreased** by **-87** offences or by **-2.5%**. The total for Q4 2014 was **896** and the total for 2014 was **3,393** as can be seen in Figures 2 and 3:

2.2 TRENDS

All crime (Crimes Against The Person, Crimes Against The Community and Crimes Against Property) in Q4 2014 **increased**, however Q4 2014 presents the **10**th **quarter in a row where offences have remained under 1,000 per quarter**. In the last 5 years All Crime has **decreased** by **26%** from **4,575** to **3,393** (2010 to 2014). This can be seen in Figure 4, which shows crime for the last 20 quarters, with Q4 figures highlighted in boxes:

3. CRIMES AGAINST THE PERSON

3.1 SUMMARY


Figure 6: Crimes Against The Person (Last 5 year comparison 2010 – 2014)

Crimes Against The Person offences in Q4 2014 **increased** by **+4** offences or **+2.6%** compared to Q3 2014. When compared to 2013, Crimes Against The Person has **decreased** by **-80** offences or **-13.0%**. The total for Q4 2014 was **156** and the total for 2014 was **535** as can be seen in Figures 5 and 6:

3.2. TRENDS

Crimes Against The Person continues to **decrease** with Q4 2014 being the **18th consecutive quarter under 200 offences**. Crimes Against The Person **decreased** from **615** offences in 2013 to **535** offences in 2014, reinforcing the view that **the long term trend of Crimes Against The Person** is **decreasing**. A summary of Crimes Against The Person for the last 20 quarters can be seen in Figure 7, with Q4 figures highlighted in boxes:

4. FIREARM INCIDENTS


Firearm Offences are included within Crimes Against The Community (Section 5); however Firearm Incidents² may not necessarily be recorded as offences, as often there is no suspect or even a victim.

4.1 SUMMARY

In Q4 2014 there were **10** firearm incidents, of which **9** were confirmed firearm incidents and **1** incident involving the recovery of a firearm and or ammunition. This compares to **3** confirmed firearm incidents in Q3 2014. In Q4 2013, there were **3** confirmed firearms incidents and **1** incident involving the recovery of a firearm and or ammunition.

There was a **decrease** (**-14**) in year on year firearm incidents with **25** in 2014 compared to **39** in 2013. This can be seen in Figure 8, which shows a 5 year comparison of firearm incidents from Q1 2010 to Q4 2014:






² To enable accurate recording, analysis and reporting of firearm incidents, the BPS classifies firearm incidents into 2 categories which are split into Confirmed or Recovery Of A Firearm and Or Ammunition. An Confirmed incident is where a person has been shot (fatally or wounded), a person has been shot at and corroboration is provided by forensic recovery of ballistic material, CCTV footage showing a firearm, reliable witness testimony or a person is charged with a firearms offence connected to the incident, a firearm is used in the commission of a criminal act and corroboration has been obtained, or a report of a firearm discharged and forensic material (bullet casings) have been recovered. A Recovery Of A Firearm and Or Ammunition is where a firearm, ammunition or imitation firearm is recovered by police.

4.2 FIREARM TRENDS

In 2014 there were **9** firearms recovered, **2** fatalities and **8** injuries by firearms. In comparison, there were **9** firearms recovered in 2013, **3** fatalities and **5** injuries. This brings the total number of persons shot since Q1 2010 to **81**, of which **22** have been fatal shootings. Figure 9 (below) shows a 5 year comparison of firearm fatalities and injuries from Q1 2010 to Q4 2014:

5. CRIMES AGAINST THE COMMUNITY

5.1 SUMMARY


Figure 11: Crimes Against The Community (Last 5 year comparison 2010 – 2014)

Crimes Against The Community offences in Q4 2014 **increased** by **+33** offences or **+28.4%** compared to Q3 2014. When compared to 2013, Crimes Against The Community has **decreased** by **-24** offences or by **-4.5%**. The total for Q4 2014 was **149** and the total for 2014 was **507** as can be seen in Figures 10 and 11:

5.2 TRENDS

Crimes Against The Community **decreased** from **531** offences in 2013 to **507** offences in 2014, reinforcing the view that **the long term trend of Crimes Against The Person** is **decreasing**. A summary of Crimes Against The Community for the last 20 quarters can be seen in Figure 12, with Q4 figures highlighted in boxes:

6. CRIMES AGAINST PROPERTY

6.1. SUMMARY


Figure 14: Crimes Against Property (Last 5 year comparison 2010 – 2014)

Crimes Against Property offences in Q4 2014 **increased** by **+12** offences or **+2.1%** compared to Q3 2014. When compared to 2013, Crimes Against Property has **increased** by **+17** offences or by **+0.7%**. The total for Q4 2014 was **591** and the total for 2014 was **2,351** as can be seen in Figure 13 and 14:

6.2 TRENDS

Of the **591** total offences in Crimes Against Property of Q4 2014, four categories saw an **increase** in offences; Burglary - Residential (**+24**), Fraud and Deception (**+8**), Criminal Damage (**+5**) and Theft of Property (**+2**). The most notable change in 2014 has been in Motor Vehicle Thefts which showed an **increase** (**+182**) from **648** offences in 2013 to **830** offences in 2014. A summary of Crimes Against Property for the last 20 quarters can be seen in Figure 15, with Q4 figures highlighted in boxes:

7. TRAFFIC COLLISIONS

7.1 SUMMARY


Figure 17: Traffic Collisions (Last 5 year comparison 2010 – 2014)

Traffic Collisions³ in Q4 2014 **decreased** by **-67** or **-18.1%** compared to Q3 2014. When compared to 2013, Traffic Collisions **decreased** by **-375** or **-21.1%**. The total for Q4 2014 was **303** and the total for 2014 was **1399** as can be seen below in Figures 16 and 17:

7.2 TRENDS

Traffic Collisions continue to **decrease** on a yearly comparison. There was an **average of 27 traffic collisions a week in 2014 compared to 34 traffic collisions in 2013.** A summary of Traffic Collisions for the last 20 quarters can be seen in Figure 18, with Q4 figures highlighted in boxes:

8. DRUG ENFORCEMENT ACTIVITY

Drug Enforcement Activity refers to policing activity against drugs seized at the border, or activity that has led to arrests or seizures in Bermuda.

8.1 SUMMARY


Figure 20: Drug Enforcement Activity (Last 5 year comparison 2010 – 2014)

Drug Enforcement Activity in Q4 2014 **increased** by **+44** or **+51.2%** compared to Q3 2014. In comparison to 2013, Drug Enforcement Activity for 2014 has **increased** by **+68** offences or **+24.4%**. The total for Q4 2014 was **130** and the total for 2014 was **347** as can be seen in Figures 19 and 20:

8.2 TRENDS

Drug Enforcement Activity has **decreased** since 2011; however during 2014 there has been a steady **increase** in enforcement activity. A summary of Drug Enforcement Activity for the last 20 quarters can be seen in Figure 21, with Q4 figures highlighted in boxes:

8.3 Drug Seizures

The Bermuda Police Service continues to work with its partners both locally and overseas to disrupt the trafficking of controlled drugs. These partners include HM Customs Bermuda, U.S. Customs and the U.S. Drug Enforcement Administration. Despite these partnerships, controlled drugs are still entering Bermuda which is evidenced in the number of 'street' level drug seizures. This can be seen in Figure 22, which shows Drug Seizures by Location, by quarter:

Figure 22 shows the majority of drugs seized in 2014 were at street level (237) while there were 76 seizures at ports (including LF Wade) and 1 overseas seizure.

8.4 Drug Seizures Type Q4 2014

An estimated total of **14.2 kg** of controlled drugs with an estimated street value of **\$736,888** was seized in Q4 2014 with Cannabis being the most common drug with **14.14 kg** seized at a value of **\$706,835**. Crack Cocaine was the next most common drug seized in Q4 2014 with **0.01 kg** seized at a value of **\$29,813**. The type, weight and value of the drugs seized broken down by Port, Street and Overseas seizures can be seen below in Figure 23:

8.5 Drug Seizure Type 2014

An estimated total of **80.44 kg** of controlled drugs with an estimated street value of **\$5.1 million** was seized in 2014. Cannabis was the most common drug with **78.27 kg** seized at a value of **\$3.9 million**. By comparison, in 2013 **22.6 kg** of Cannabis was seized with a value of **\$1.1 million**. Cannabis Resin was the next most common drug seized in 2014 with **0.76 kg** seized at a value of **\$76,103**. The type, weight and value of the drugs seized broken down by Port, Street and Overseas seizures for 2014 can be seen in Figure 24:

9. TRAFFIC ENFORCEMENT ACTIVITY -

9.1 SUMMARY


Figure 26: Traffic Enforcement Activity (Last 5 year comparison 2010 - 2014)

Traffic Enforcement Activity in Q4 2014 **decreased** by **-227** or **-3.7%** compared to Q3 2014. When compared to 2013, Traffic Enforcement Activity has **decreased** by **-5,148** or **-15.7%**. The total for Q4 2014 was **5,938** and the total for 2014 was **27,671** as can be seen below in Figures 25 and 26:

9.2 TRENDS

Traffic Enforcement Activity has **decreased** from **6,615** offences in Q3 2014 to **5,938** offences in Q4 2014. This is comprised of **278** tickets issued for Speeding, **243** tickets issued for Disobeying a Traffic Sign and **183** tickets issued for Use of a Handheld device. Impaired Driving **increased** from **22** offences in Q3 2014 to **54** offences in Q4 2014. Q4 2014 represents the **lowest quarter since Q1 2008**. Traffic Enforcement Activity has decreased from **32,819** in 2013 to **27,671** in 2014. 10. INCIDENTS - CALLS FOR SERVICE

10.1 SUMMARY


Figure 26: Incidents - (Last 5 year comparison 2010 - 2014)

Incidents refer to all police activity and also to calls for service that have been recorded on the police computer system (New World System). Incidents in Q4 2014 **decreased** by **-730** or **-13.2%** compared to Q3 2014. When compared to 2013, Incidents – Calls For Service has **decreased** by **-6,187** or **-22.7%**. The total for Q4 2014 was **4,790** and the total for 2014 was **21,029** as shown in Figures 25 and Figures 26:

11.1 SUMMARY


Figure 29: Arrests - All Offences (Last 5 year comparison 2010 – 2014)

Arrests refer to those persons arrested and brought into police custody. Arrests in Q4 2014 **increased** by **+9** or **+1.4%** compared to Q3 2014. When compared to 2013, arrests have **decreased** by **-254** or **-9.4%**. The total for Q4 2014 was **640** and the total for 2014 was **2,456** as can be seen in Figures 28 and 29:

12. STOP AND SEARCHES

12.1 SUMMARY

Stop and Searches are conducted in a proportionate and accountable manner and only when Police Officers have occasion to exercise lawful powers. They are carried out with courtesy, consideration and respect for the individual being stopped. While the figures are not performance indicators, they are a reflection of the frequency of engagement between proactive Police Officers and Prolific Priority Offenders. They provide an indication of police activity, particularly regarding the number of highly visible patrols in the community.


Figure 36: Stop and Searches (Last 5 Quarter comparison Q4 2013 – Q4 2014)

There were **518** Stop and Searches in Q4 2014, an **increase** of **269** or **108.0%** compared to Q3 2014. When compared to 2013, Stop and Searches have **decreased** by **-1,692** or **-54.0%**. The total for Q4 2014 was **518** and the total for 2014 was **1,441** as can be seen in Figures 36 and 37:

13. PROCEEDS OF CRIME ACT (POCA) SEIZURES

13.1 SUMMARY


Figure 39: POCA Seizures (Last 5 Quarter comparison Q4 2013 – Q4 2014)

\$49,829.00 was seized in Q4 2014, compared to **\$65,706.00** in Q3 2014. This is a decrease of **\$15,877.00** or **-24.2%**. The total amount of cash seized for 2014 was **\$623,115.96** compared to **\$423,380.01** which was confiscated in 2013. This is an increase of **\$199,735.95** or **+47.2%**. There were **8** cash seizures in 2014, compared to **28** in 2013. This can be seen in Figures 39 and 40.
