

BPS Crime Statistics (Q4 2009)

Executive Summary

- •All Crime has decreased -9.7% in Q4 2009 compared to Q3 2009, by -143 offences.
- •All Crime has decreased -3.9% in 2009 compared to 2008, by -215 offences.

•The figures reflect large decreases in burglary, motor vehicle theft and theft of property, however Crimes Against The Person and Crimes Against The Community offences have both increased.

Executive Summary (2)

- •Crimes Against The Person increased by 6.2% in 2009 compared to 2008. It is now at its highest yearly level for 5 years. This is primarily due to less serious and non-injury Assaults increasing by 91 (to 592) and Serious Assaults increasing by 12 (to 110). There were 6 murders in 2009 compared to 5 in 2008.
- •Crimes Against The Person. Q4 2009 was the **third highest** quarterly figure for Crimes Against The Person since 2005, with **246**. There were **3** murders in Q4 2009, the first time there were more than 2 murders in a quarter since 2005. Offences Against Children increased by 4 (to **12**). However, Q4 2009 comparison to Q3 2009 shows that Serious Assaults are down by **-3** (29 to 26) and Robbery is down by **-5** (**35** to **30**).

Executive Summary (3)

- •Crimes Against Property is down -11% or -435 offences (to 3,510) in 2009 compared to 2008. The yearly total for Crimes Against Property in 2009 is the lowest yearly figure for the last 5 years. This is mainly due to all burglary offences decreasing by -162 and theft of property decreasing by -177 (to 1,003).
- •Crimes Against Property is also down -19% or -190 (994 to 804) when Q4 2009 is compared to Q3 2009. Residential burglary is down -32 (to 197), theft of property down -80 (to 218), Criminal Damage is down -48 (to 95) and Motor Vehicle Theft is down by -36 (to 170). TWOCS are now at their lowest quarterly level for 5 years.

Executive Summary (4)

- •Crimes Against The Community increased by 22.3% in 2009 compared to 2008. It is at its highest level for 5 years. This is primarily due to Antisocial Behaviour which has increased by 113 (to 636) and Firearm Offences, which have increased by 21 (to 38). It is noticeable that all the 5 categories used to calculate Crimes Against The Community have increased year on year.
- •Crimes Against The Community increased by 23.3% in Q4 2009 compared to Q3 2009. It is at its highest quarterly level for 5 years, with 254 offences recorded for Q4 2009. This is again manly due to Antisocial Behaviour which has increased by 32 (to 173), Other Weapons which have increased by 11 (to 29) and Firearms Offences which have increased by 6 (to 17).


Executive Summary (5)

- •Traffic Collisions. The long term trend continues to decrease with 2009 being the lowest year since 2005. However we are still concerned about the number of fatal collisions (17 fatal collisions in 2008 compared to 13 in 2009).
- •Drug enforcement up 37.4% year on year and by 19.3% when Q4 2009 is compared to Q3 2009.
- •Traffic Enforcement is up 54% year on year (from 35,327 to 54,386).
- •Police Activity and Calls For Service increased by 34.3% year on year, (from 29,350 to 39,429).


Executive Summary (6)

- •Arrests are up 40% year to year and have increased by 3.5% in Q4 2009 to the highest level quarterly recorded of 1,309. Discounting warrants, the most arrests were for drugs (135), with 12 additional arrest for importation.
- •Police **Stop and Search** activity increased by **68.4%** over the previous quarter or by **550** (to **1,354**).




Crimes Against The Person




Crimes Against Property




Crimes Against The Community




Traffic Collisions




Police Traffic Collisions



Traffic Enforcement Activity




Drug Enforcement Activity








